# GOVERNMENT ORDER NO.MED 398 MMC 2019, BANGALORE; Dated: 09-10-2019

The Government has recommended to issue recognition to newly start B.Sc Nursing Course from the year 2019-20 admission limited to 40 (Forty) seats in Vidhyodhaya College of Nursing, Bangalore of Vidhyodhaya Foundation, No.3, Sy. No. 41/3, Shettyhalli Main Road, Chikkabanavara, Bangalore— 560090 by exercising powers conferred u/s 45(5) of the Rajiv Gandhi University of Health Sciences Act, 1994 subject to the following terms and conditions:

## **TERMS & CONDITIONS**

The said Institution has to give 20% of the B.Sc Nursing course Seats out of the above said allotted seats in favour of the government for allotment.

2. Has to obtain permission from Rajiv Gandhi University of Health Sciences for recognition of above said course.

3. Has to strictly follow Bye-laws prescribed by the Rajiv Gandhi University of Health Sciences and has to strictly possess fundamental facilities prescribed by the University.

- 4. The said institute has to give admissions to the prescribed students only after obtaining permission/recognition from the Rajiv Gandhi University of Health Sciences. If this is violated, Criminal Case will be initiated as per Karnataka Act, 1991 (Prohibition on admission of students to Un-Aided and recognized educational institutions).
- 5. Has to compulsorily follow the instructions and orders issued by the State Government and the University from time to time.
- 6. Recognition has to be issued only after confirming that the said institution has own its own Hospital.
- 7. Admission of students has to be given only in the prescribed prohibiting ratio to the Management Quota and Government quota for BPT Course from time to time by the government and regulations of selection of candidates for admission to Karnataka Nursing, Pharmacy and Physio-therapy, 2003.
- 8. The Government will not sanction any Aid in favour of the above said institution. This is considered under the condition that the said institution has been permanently un-aided institution.
- 9. If any of the above conditions are violated by the College, the Recognition given to the said Institution shall be withdrawn as per Section 48 of Rajiv Gandhi University of Health Sciences, 1994.
