PROPOSAL:

The Registrar of Karnataka State Nursing Council, Bangalore in his letter referred to above has filed proposal to the government stating that, an Inspection team was constituted to inspect the fundamental facilities possessed by the school, as per the reference of the Report of the Inspection Team to issue recognition to newly start Diploma in Nursing Course from the year 2019-20 admission limited to 60 seats in Magnus School of Nursing of Vidhyodhaya Foundation, No.36, Vinayaka Nagara Layout, Binnamangala Village, Nelamangala Taluk, Bangalore -562123.

After careful verification of the subject with relevant documents, the Government has passed this order to issue recognition to newly start Diploma in Nursing Course from the year 2019-20 admission limited to 60 seats in Magnus School of Nursing of Vidhyodhaya Foundation, No.36, Vinayaka Nagara Layout, Binnamangala Village, Nelamangala Taluk, Bangalore - 562123.

As per the points described in the proposal, the Government has recommended to issue recognition to newly start Diploma in Nursing Course from the year 2019-20 admission limited to 60 (Sixty) seats in Magnus School of Nursing of Vidhyodhaya Foundation, No.36, Vinayaka Nagara Layout, Binnamangala Village, Nelamangala Taluk, Bangalore -562123 subject to the following terms and conditions:

TERMS & CONDITIONS

1. The said Institution has to give 10% of the Seats out of the above said allotted seats in favour of the government for allotment.
2. Has to obtain permission from Karnataka State Nursing Council.
3. Has to follow Syllabus as prescribed by the Karnataka State Nursing Council and the Action Plan of the Midwife and Nursing Examination Board.
4. Has to possess Fundamental Facilities as prescribed by the Karnataka State Nursing Council.

5. Has to own its own Hospital and Building in due course of time of 05 years.
6. Has to compulsorily follow the orders and instructions issued from time to time by the Government of Karnataka and Karnataka State Nursing Council.
7. Has to admit only the prescribed number of students as per the rules and regulations issued from time to time by the government and also as per the regulations of the Karnataka Selection of Candidates for Admission to Courses of Diploma in Psychiatry, Midwifery, General Nursing, 2003. And should not admit additional students for any reason. If this is violated Criminal Prosecution will be initiated as per Karnataka Prohibition on Admission of Students to Un-Aided and Recognized Educational Institutions Act, 1991.
8. The Government will not sanction any Aid, financial facilities in favour of the above said institution. This is considered under the condition that the said institution has been permanently un-aided institution.
9. If any of the above conditions are violated by the College, the Recognition given to the said Institution shall be withdrawn.
